Legislative Progress

was pleased to report in last month's *Advisor* that I had reviewed Governor Bentley's proposed pension reform legislation and it made reasonable and modest changes to the teacher and public employee retirement systems. Most importantly, the terms of the legislation upheld the promises made to current employees, whether vested or not, and made no changes that affected their benefits.

On March 7, I stood with Governor Bentley, Speaker of the House Mike Hubbard, President Pro Tem of the Senate Del Marsh and the sponsors of the pension reform bill from the House and Senate to announce the introduction of the pension reform bill in the Legislature. I chose to make this show of support for the bill because it is responsible and needed legislation. I am grateful to Governor Bentley, Speaker Hubbard, and President Pro Tem Marsh for askBy David G. ing the RSA to participate in this process. They listened when the RSA made our expertise available to them to assist in crafting the best bill possible: one that would make necessary changes to our systems to keep it viable, but that would also keep teachers' and public employees' benefits strong so that Alabama will continue to attract and retain the best candidates possible for these critically important jobs. That is simply good government.

I am also grateful for the leadership of the bill's sponsors, Senator Arthur Orr and Representatives Jamie Ison and Mac McCutcheon, who have committed to shepherd this bill through the legislative process while protecting the integrity of the original bill. While it may be tempting to some members of the Legislature to seek to amend this bill, the terms of reform in the current law are interdependent. That is to say that a change to any individual component of the bill, such as the retirement age or the benefit factor, for instance, may drastically change the outcome of the reforms and thwart the bill's intended purpose. Responsible leaders such as Senator Orr and Representatives Ison and McCutcheon recognize the complexity of this type of legislation and have pledged to protect it.

Senator Orr is leading the charge on another piece of much needed legislation that also protects RSA's integrity. He passed a bill in the Senate that requires teachers and public employees convicted of a felony offense related to their public position to forfeit the right to retirement benefits. Representative Joe Hubbard has maneuvered this legislation through a House committee and could be before the full House and become law at any time. This is a reform of the law that RSA has long advocated and another example of good government.

RSA's media investments have primed the pump for Alabama tourism for the last twenty years. Tourism was a \$1.8 billion industry the year the RTJ Trail started. 

AAA Four Diamond Award (<u>www.aaa.com</u>)

Continuing a 75-year tradition, AAA's professionally trained inspectors use published guidelines to conduct unannounced lodging and restaurant evaluations. A total of 1,491 hotels throughout the U.S., Canada, Mexico, and the Caribbean received the Four Diamond Rating. Renaissance Ross Bridge is one of eight hotels in Alabama (six are part of the RTJ Resort Collection) to receive the Four Diamond rating. Ross Bridge received the honor for the sixth consecutive year. Collectively, Four Diamond lodging represents just 4.8 percent of the current 31,000 AAA/CAA Approved and Diamond Approved lodgings.

hen you read about GE paying no corporate federal taxes in 2010 while getting a \$3.2 billion rebate, does your blood start to boil?

If you listened to the corporate whining, you probably thought companies like GE paid 35% in federal taxes. Not so. It's a rare company that ponies up that amount.

For too long the American public has been hornswoggled by this century's "robber barons."

Remember, it was our tax dollars that saved the hides of many of these multinationals with colossal bailouts, and how do they say thanks?

By not paying their taxes. Nada, zero, zilch. And it's legal, thanks to Congress.

Want to know who these corporate culprits are? Look no further than the Wall of Shame where you will find the top ten Corporate Tax Dodgers, many who brought this country to the brink of an economic meltdown.

- Exxon Mobil. In 2009, Exxon Mobil made \$19 billion in profits. Not only did Exxon avoid paying any federal income taxes that year, it actually received a \$156 million rebate from the IRS, according to its SEC filings.
- 2) Bank of America. Last year, Bank of America received a \$1.9 billion tax refund from the IRS, even though it made \$4.4 billion in profits and just a couple of years ago received a bailout



- General Electric. Over the past five years, while General Electric made \$26 billion in profits in the United States, it received a \$4.1 billion refund from the IRS.
- Chevron. In 2009, Chevron received a \$19 million refund from the IRS after it made \$10 billion in profits.
- 5) **Boeing**. Last year, Boeing, which received a \$30 billion contract from the Pentagon to build 179 airborne tankers, got a \$124 million refund from the IRS.
- 6 Valero Energy. Last year, Valero Energy, the 25th largest company in America with \$68 billion in sales last year received a \$157 million tax refund check from the IRS and, over the past three years, it received a \$134 million tax break from the oil and gas manufacturing tax deduction.
- 7) Goldman Sachs. In 2008, Goldman Sachs paid only 1.1 percent of its income in taxes even though it earned a profit of \$2.3 billion and received an almost \$800 billion bailout from the Federal Reserve and U.S. Treasury Department.
- 8) **Citigroup**. Last year, Citigroup made more than \$4 billion in profits but paid no federal income taxes, even though it received a \$2.5 trillion bail-

out from the Federal Reserve and U.S. Treasury.

- 9) ConocoPhillips. ConocoPhillips, the fifth largest oil company in the United States, made \$16 billion in profits from 2007 through 2009, but received \$451 million in tax breaks through the oil and gas manufacturing deduction during those years.
- 10) Carnival Cruise Lines. Over the past five years, Carnival Cruise Lines made more than \$11 billion in profits, but its federal income tax rate during those years was just 1.1 percent.

A labamians traditionally have been a giving people, with their state often ranking among the more generous states based on a percentage of income donated to charity.

"Alabama is one of the nation's poorer states by a number of metrics," the website states. "The average income per taxpayer is the ninth lowest in the country, and the percentage of people living in poverty is the sixth highest. Despite this, residents of the state are very generous, and charitable donations per taxpayer are the seventh highest in the country.
