We have conducted the 2015 Retired #1 Representative Board election of Retirement Systems of Alabama - TRS in accordance with the bylaws of the system.

- We have performed all election procedures, including ballot selection, printing and mailing, Internet and Telephone vote collection and receipt of return mail ballots. Mail-in ballots, Internet and Telephone tabulation were subject to 100% verification.

Final tabulations have been completed and are attached hereto as follows:

- Election Results/Statistical Results: Tabulation of votes by candidate in ranked order with percentage of total valid votes received. Tabulation of voted ballots by position, by candidate, Mail-in, Internet and Telephone with total number of votes, undervotes and overvotes. Undervotes are created when a member does not vote for the maximum number of candidates allowed (i.e. 1). Overvotes are created when the member votes for more than the maximum number allowed (i.e. 1). The vote is void. Overview of total number of voters, voter turnout, percentage turnout by method of voting and voids.

Based upon our review of the election procedures and results, it is our opinion that the 2015 Retired #1 Representative Board election of the Retirement Systems of Alabama - TRS has been carried out in accordance with the system bylaws and election rules, and the results thereof are accurately reflected in the attached exhibits.
