Flu Shots offered at PEEHIP workplaces

- ◆ PEEHIP has recently been notified that some pharmacies in the state are offering their services to come on-site to the school systems and administer flu shots to PEEHIP members and their dependents. While PEEHIP encourages all members to receive the flu shot this year, the Alabama Department of Public Health (ADPH) is currently the only PEEHIP approved vendor to come on-site to a PEEHIP participating workplace and offer flu shots or wellness screenings. Since July of 2011, PEEHIP has not covered any services, including flu vaccinations, when given at the schools or other work sites unless the services are specifically provided under the contract between PEEHIP and the ADPH.
- ◆ This means that flu shots or wellness screenings obtained at your workplace by a vendor other than the ADPH will not be covered by your PEEHIP benefits, and will not be eligible for reimbursement. In order for PEEHIP members to avoid charges for flu shots or wellness screenings at their workplace, please refrain from obtaining that service at your workplace from any vendor other than the ADPH.
- ◆ Although PEEHIP is now allowing participating pharmacies to administer the flu vaccine to PEEHIP covered members at the pharmacy location, PEEHIP does not allow a participating pharmacy to administer the flu vaccine at a school location. PEEHIP covered members can also continue obtaining a flu shot at their in-network healthcare provider or through the ADPH.
- ◆ Please immediately communicate this information to your school nurses, employees and the pharmacies that may be planning on providing on-site vaccinations clinics in the future. If any benefit changes or updates are ever made in the future that allow other vendors to offer these services on-site, PEEHIP will send written notification of the update at that time specifically for your school.

PEEHIP Wellness Program Deadline is August 31, 2015

- ◆ Remember that the deadline to complete all of your required activities for the PEEHIP *Team Up for Health* Wellness Program is August 31, 2015.
