### ***PEEHIP Wellness Program Deadline Extended to 8/31/2015***

- ◆ As of today, 84% or nearly 125,000 members have completed all required activities as part of the PEEHIP Team Up for Health Wellness Program. Due to the amazing completion rate, PEEHIP would like to extend the time available so that even more members can reach 100% complete. It has always been PEEHIP's goal for 100% of the eligible membership to reach completion so that no members are charged the monthly wellness premium. Because of this, **the deadline to complete all required activities has been extended to August 31, 2015**. This is a FINAL deadline and cannot be extended. If you miss this deadline, you will be charged the wellness premium beginning with the October coverage period. If you complete your wellness requirements after August 31, 2015, the wellness premium will be waived prospectively (not retroactively). ### ***PEEHIP Flexible Spending Accounts***

- ◆ The PEEHIP program is dedicated in finding ways to save our members money. In doing so PEEHIP offers two Flexible Spending Account (FSA) plans available to all active employees. A Flexible Spending Account allows employees to pay for eligible healthcare and dependent daycare expenses with tax-free dollars.
