Since 1939, The Teachers' Retirement System (TRS) has provided benefits to qualified members employed by state-supported educational institutions, including public employees of K-12 school systems, two-year Community Colleges, four-year higher education institutions, and education state agencies. Our goal is to provide exceptional member services, including accurate and timely benefit payments to our eligible retirees, beneficiaries and survivors.

**TRS Tier 1 Active Members:** Any member of the TRS who had service credit with the ERS or TRS prior to January 1, 2013.

**TRS Tier 2 Active Members:** Any member who had no service credit with the ERS or TRS prior to January 1, 2013.
