2 ENROLLED, An Act,

3 Relating to retirement; to extend the provisions of
4 Act 2017-367 to allow local units participating in the
5 Employees' Retirement System additional time to elect to come
6 under the provisions of the act.

7 BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

8 Section 1. The provisions of Act 2017-367 as they
9 apply to employers participating in the Employees' Retirement
10 System pursuant to Sections 36-27-6, 36-27-7, and 36-27-7.1,
11 Code of Alabama 1975, shall be extended if a participating
12 employer elects to come under the provisions of Act 2017-367
13 by official resolution on or before October 31, 2018. Upon
14 such election by official resolution on or before October 31,
15 2018, the lump-sum payments provided under Act 2017-367 shall
16 be paid to all eligible recipients who are entitled to receive
17 a lump-sum payment under Act 2017-367 and are receiving a
18 benefit as of April 1, 2018, by the Employees' Retirement
19 System in December 2018. Any employer making such election
20 shall bear the cost of the lump-sum payment paid to its
21 retirees, as provided in Act 2017-367.

22 Section 2. This act shall become effective
23 immediately following its passage and approval by the
24 Governor, or its otherwise becoming law.
