2 ENROLLED, An Act,

3 Relating to Franklin County; to propose an amendment
4 to the Constitution of Alabama of 1901, to allow mayors in
5 Franklin County to participate in the Employees' Retirement
6 System.

7 BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

8 Section 1. The following amendment to the
9 Constitution of Alabama of 1901, is proposed and shall become
10 valid as a part of the Constitution when all requirements of
11 this act are fulfilled:

12 PROPOSED AMENDMENT

13 In Franklin County, mayors of municipalities that
14 participate in the Employees' Retirement System of Alabama may
15 participate in the Employees' Retirement System of Alabama
16 upon the same terms and conditions as may be specified by law
17 for any other employee in the same retirement system. A mayor
18 holding office at the time of the ratification of this
19 amendment shall be eligible to purchase service credit in the
20 Employees' Retirement System for the time the official has
21 served in the current office. No person may participate in
22 both a supernumerary program and the Employees' Retirement
23 System based on the same service.

24 Upon ratification of this constitutional amendment
25 and contingent upon the ratification of the Constitution of

1 Alabama of 2022, the Code Commissioner shall number and place
2 this amendment as appropriate in the constitution based upon a
3 logical sequence and the particular subject or topic of the
4 amendment. In this amendment, the Code Commissioner may change
5 capitalization, spelling, and punctuation for the purpose of
6 style and uniformity; correct manifest grammatical, clerical,
7 and typographical errors; and correct incorrect
8 cross-references. When publishing the Constitution of Alabama
9 of 2022, the Code Commissioner may omit this instructional
10 paragraph.

11 Section 2. An election upon the proposed amendment
12 shall be held in accordance with Section 284.01 of the
13 Constitution of Alabama of 1901, now appearing as Section
14 284.01 of the Official ReCompilation of the Constitution of
15 Alabama of 1901, as amended, and the election laws of this
16 state.

17 Section 3. The appropriate election official shall
18 assign a ballot number for the proposed constitutional
19 amendment on the election ballot and shall set forth the
20 following description of the substance or subject matter of
21 the proposed constitutional amendment:

22 "Relating to Franklin County, proposing an amendment
23 to the Constitution of Alabama of 1901, to allow mayors to
24 participate in the Employees' Retirement System.

25 "Proposed by Act _____"

1 This description shall be followed by the following
2 language:
