4 Relating to retirement; to extend the provisions of Act
5 2022-229 to allow local units participating in the Employees'
6 Retirement System additional time to elect to come under the
7 provisions of the act.

8 BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

9 Section 1. The provisions of Act 2022-229 as they apply
10 to employers participating in the Employees' Retirement System
11 pursuant to Sections 36-27-6, 36-27-7, and 36-27-7.1, Code of
12 Alabama 1975, shall be extended if a participating employer
13 elects to come under the provisions of Act 2022-229 by
14 official resolution on or before October 31, 2023. Upon such
15 election by official resolution on or before October 31, 2023,
16 the lump-sum payments provided under Act 2022-229 shall be
17 paid to all eligible recipients who are entitled to receive a
18 lump-sum payment under Act 2022-229 and are receiving a
19 benefit as of April 1, 2023, by the Employees' Retirement
20 System in December 2023. Any employer making such election
21 shall bear the cost of the lump-sum payment paid to its
22 retirees, as provided in Act 2022-229.

23 Section 2. This act shall become effective immediately
24 following its passage and approval by the Governor, or its
25 otherwise becoming law.
