This bill would propose an amendment to the Constitution of Alabama of 2022, relating to Dale County, to allow mayors in municipalities in the county to participate in the Employees' Retirement System under certain conditions.

BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

Section 1. The following amendment to the Constitution of Alabama of 2022, is proposed and shall become valid as Section 23-8.01 of the constitution when all requirements of this act are fulfilled:

In Dale County, the mayor of a municipality that participates in the Employees' Retirement System of Alabama may participate in the Employees' Retirement System of Alabama upon the same terms and conditions as may be specified by law for any other employee of the municipality in the same retirement system. A mayor holding office at the time of the ratification of this amendment shall be eligible to purchase service credit in the Employees' Retirement System for the time the official has served in the current office. No person may participate in both a supernumerary program and the Employees' Retirement System based on the same service.
