4 Relating to the Employees' Retirement System; to amend Section 36-27-8.2, Code of Alabama 1975, to temporarily permit 5 6 certain retired individuals performing duties as school 7 resource officers or as correctional officers to serve without suspension of his or her retirement allowance. 8 9 BE IT ENACTED BY THE LEGISLATURE OF ALABAMA: 10 Section 1. Section 36-27-8.2 of the Code of Alabama 11 1975, is amended to read as follows: "§36-27-8.2 12 13 (a) Any person who is retired under the Employees' 14 Retirement System may perform duties in any capacity, 15 including as an independent contractor, with any employer 16 participating in the Employees' Retirement System or the 17 Teachers' Retirement System without suspension of his or her retirement allowance provided that (1) the person is not 18 employed in a permanent full-time capacity and (2) the 19 20 person's compensation from the employer in calendar year 2016 21 does not exceed thirty thousand dollars (\$30,000). Beginning 22 in calendar year 2017, and each calendar year thereafter, the 23 annual earning limit shall be increased by the same percentage increase as the increase in the Consumer Price Index for all 24 urban consumers as published by the U.S. Department of Labor, 25 26 Bureau of Labor Statistics. Any increase in the annual earning limit shall be rounded to the next lowest multiple of one 27 28 thousand dollars (\$1,000) with any amount in excess of the one

thousand dollar (\$1,000) multiple considered in determining the increase for the following year. Each adjustment shall be based on the increase in the index for the preceding 12-month period ending on September 30 and the increase shall be effective for the following calendar year.

34 (b) Any person serving as an elected official who has 35 retired from the Employees' Retirement System may serve for 36 compensation in an elected public office with the state, a 37 county, or an incorporated municipality without suspension of 38 retirement benefits; provided that under no circumstances 39 shall such a person participate in or accrue additional benefits under the Teachers' Retirement System or the 40 41 Employees' Retirement System, and provided that under no 42 circumstances shall a person whose retirement is based upon 43 service as an elected official continue in or return to such 44 office and receive both pension benefits and salary; provided 45 further, that this subsection shall apply to elected officials 46 whose participation in the Teachers' Retirement System or the 47 Employees' Retirement System is constitutionally required to 48 be upon the same terms and conditions as specified by law for 49 other employees in the retirement system if such elected 50 official's compensation does not exceed the annual earning 51 limits provided in subsection (a).

(c) The responsibility for compliance with the provision of this section is placed upon the employing authority, and each retiree performing duties under this section shall certify to the employer any information required in order to carry out this section. The retiree shall provide
