8	WHEREAS, attracting and maintaining an effective
9	workforce is vital to the welfare of this state; and
10	WHEREAS, formulating, and periodically examining and
11	revising, as necessary, the benefit packages provided for
12	state employees, education personnel, and teachers will
13	ensure that the benefit packages remain fair, competitive,
14	and sustainable; and
15	WHEREAS, the health insurance plans for state
16	employees, education employees, and teachers are developed
<u>1</u> 7	and administered by separate boards and employees of those
18	boards; and
19	WHEREAS, the health insurance plan for state
20	employees is designed by the State Employees' Insurance
21	Board to provide medical benefits for active and retired
22	state employees and dependents in a manner that provides a
23	reasonable relationship between the benefits provided and
24	the costs incurred in order to provide a reasonable
25	assurance of stability in future years of the plan; and
26	WHEREAS, the health insurance plan for education
27	personnel and teachers is designed by the Public Education

28 Employees' Health Insurance Board to provide medical



- 29 benefits for active and retired education personnel, 30 teachers, and dependents in a manner that provides a 31 reasonable relationship between the benefits provided and 32 the costs incurred in order to provide a reasonable 33 assurance of stability in future years of the plan; and 34 WHEREAS, a review of the health insurance plans 35 offered to state employees, education personnel, and 36 teachers cannot be fully completed without considering the 37 cost savings and efficiencies of scale that might be realized from the consolidation of the administrative 38 39 functions of the health insurance plans; now therefore 40 BE IT RESOLVED BY THE LEGISLATURE OF ALABAMA, BOTH 41 HOUSES THEREOF CONCURRING, That there is created the State 42 Employee and Education Employee Health Insurance Joint 43 Interim Study Commission to examine and review if the 44 existing health insurance benefits packages are competitive 45 with surrounding states and private industry and if savings 46 or efficiencies of scale could be realized by consolidating 47 the administrative functions of the health insurance plans 48 under a single board. (a) The study commission shall be comprised of the 49 50 following members: (1) A person appointed by the Chief Executive
- (1) A person appointed by the Chief ExecutiveOfficer of the State Employees' Insurance Board.
- (2) A person appointed by the Chief ExecutiveOfficer of the Public Education Employees' Health InsuranceBoard.

- 33 (c) A chair of a Senate Finance and Taxation
- 34 Committee and a chair of a House Ways and Means Committee

- shall serve as cochairs of the commission. The commission
- 36 shall meet as soon as practical at a time and place set by

- 96 personnel, and teachers in the surrounding southeastern
- 97 states, determine what constitutes competitive state
- 98 employee, education personnel, and teacher health insurance
- 99 benefits, and provide recommendations for modifications.
- 100 (2) Perform an in-depth analysis of the fiscal
- 101 ramifications and efficiencies of scale that might be
- 102 realized by consolidating the administrative functions and
- 103 duties of the State Employees' Insurance Board (SEIB) and
- 104 the Public Education Employees' Health Insurance Board
- 105 (PEEHIB).
- 106 (3) Examine the ability of the state to sustain any
- 107 proposed modifications to the health insurance plans.
- 108 (4) Compare projected health insurance obligations
- 109 to total State General Fund and Education Trust Fund budget
- 110 projections.
- 111 (e) The Senate and the Legislative Services Agency
- 112 shall provide the necessary staff and support to the



- 113 commission to perform its duties.
- 114 (f) (1) The Legislative members of the commission
- shall be entitled to their legislative compensation, per
- 116 diem, and travel expenses for each day they attend a meeting
- of the commission in accordance with Section 49 of the
- 118 Constitution of Alabama of 2022.
- 119 (2) Other members of the commission may be
- 120 reimbursed for necessary expenses in attending meetings of
- 121 the commission according to policies and procedures of their
- respective appointing authorities.
- 123 (g) The commission shall report its findings to the
- 124 Legislature, along with proposed legislation, not later than
- January 1, 2025, at which time the commission shall stand
- 126 dissolved.
