Section 16-25-26 and Section 36-27-8.2, as 14 amended by Act 2023-334 and Act 2023-564, of the Code of 15 Alabama 1975, are amended to read as follows: "§16-25-26 16 17 (a) Any person who is retired under the Teachers' 18 Retirement System may perform duties in any capacity, 19 including as an independent contractor, with any employer 20 participating in the Employees' Retirement System or the 21 Teachers' Retirement System without suspension of his or her 22 retirement allowance provided that (1) the person is not 23 employed in a permanent full-time capacity and (2) the 24 person's compensation from the employer in calendar year 2016 25 does not exceed thirty thousand dollars (\$30,000). Beginning in calendar year 2017, and each calendar year thereafter, the 26 27 annual earning limit shall be increased by the same percentage increase as the increase in the Consumer Price Index for all 28

29 urban consumers as published by the U.S. Department of Labor, 30 Bureau of Labor Statistics. Any increase in the annual earning 31 limit shall be rounded to the next lowest multiple of one 32 thousand dollars (\$1,000) with any amount in excess of the one 33 thousand dollar (\$1,000) multiple considered in determining 34 the increase for the following year. Each adjustment shall be 35 based on the increase in the index for the preceding 12-month period ending on September 30 and the increase shall be 36 effective for the following calendar year. 37

38 (b) Any person serving as an elected official who has 39 retired from the Teachers' Retirement System may serve for his 40or her full compensation in an elected public office with the 41 state, a county, or an incorporated municipality without 42 suspension of retirement benefits; provided that under no 43 circumstances shall such a person participate in or accrue additional benefits under the Teachers' Retirement System or 44 45 the Employees' Retirement System for that service, and 46 provided that under no circumstances shall a person whose 47 retirement is based upon service as an elected official 48 continue in or return to such office and receive both pension 49 benefits and salary; provided further, that this subsection 50 shall apply to elected officials whose participation in the 51 Teachers'-Retirement System or the Employees' Retirement 52 System is constitutionally required to be upon the same terms 53 and conditions as specified by law-for other_employees in the retirement system if such elected official's compensation does 54 55 not exceed the annual earning limits previded in subsection 56 (a). 
