SYNOPSIS:

Under existing law, certain pension, annuity, or retirement allowance benefits under the Teachers' Retirement System and the Employees' Retirement System are subject to state or municipal tax, levy, sale, garnishment, attachment, or any other related process under certain circumstances.

This bill would revise the circumstances in which an individual's pension, annuity, or retirement allowance benefits under the Teachers' Retirement System and the Employees' Retirement System are subject to certain recovery actions.

AN ACT

Relating to retirement benefits; to amend Sections 16-25-23 and 36-27-28, Code of Alabama 1975, to revise the circumstances in which an individual's pension, annuity, or retirement allowance benefits under the Teachers' Retirement System and the Employees' Retirement System are subject to certain recovery actions.

BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

29 Section 1. Sections 16-25-23 and 36-27-28, Code of
30 Alabama 1975, are amended to read as follows:

31 "§16-25-23

32 (a) Except as provided in subsection (b), the right of
33 a person to a pension; an annuity, or a retirement allowance;
34 to the return of contributions; the pension, annuity, or
35 retirement allowance itself; any optional benefit or any other
36 right accrued or accruing to any person under the provisions
37 of this chapter; and the monies in the various funds created
38 by this chapter are ~~hereby~~ exempt from any state or municipal
39 tax and exempt from levy and sale, garnishment, attachment, or
40 any other process whatsoever, and shall be unassignable except
41 as ~~in this chapter specifically~~ otherwise provided in this
42 chapter.

43 (b) (1) Restitution, fines, court costs, fees, or any
44 other financial obligations in a criminal case ordered by a
45 circuit or district court judge in this state are not subject
46 to the exemption set out in subsection (a), provided ~~all~~both
47 of the following are satisfied:

48 a. The amount of the restitution ordered is in the
49 amount of one thousand dollars (\$1,000) or greater.

50 b. The ~~person~~individual subject to the order is a
51 retiree or beneficiary who is currently receiving benefits

60 monthly benefit less any deductions for child support or
61 health insurance for any dependents, to be applied to the
62 balance of the restitution, fines, court costs, fees, or other
63 financial obligations ordered in the criminal case.

64 (3) An order under subdivision (2) shall set out all
65 of the following:

66 a. The individual's name, date of birth, and Social
67 Security number.

68 b. The amount of restitution ordered is in the amount
69 of one thousand dollars (\$1,000) or greater.

70 c. The amounts of restitution, fines, court costs,
71 fees, or any other financial obligations owed, detailed
72 individually.

73 d. The relevant case numbers.

74 e. The county in which the case was brought.

75 f. The circuit clerk's name and mailing address.

76 g. That the restitution, fines, court costs, fees, or

80 (4) The district attorney shall notify the court
81 whenever the restitution, fines, court costs, fees, or other

84 funds. Any payment received by the circuit clerk in an amount

87 information as to the retiree or the beneficiary to whom it is

90 (a) Except as provided in subsection (b), the right of
91 a person to a pension, an annuity, a retirement allowance or
92 to the return of contributions, the pension, annuity, or
93 retirement allowance itself and any optional benefit or any
94 other right accrued or accruing to any person under the
95 provisions of this article and the monies in the various funds
96 created by this chapter are ~~hereby~~ exempt from any state or
97 municipal tax and exempt from levy and sale, garnishment,
98 attachment, or any other process whatsoever and shall be
99 unassignable except as in this article specifically otherwise
100 provided.

101 (b) (1) Restitution, fines, court costs, fees, or any

143 over what was owed shall be paid back to the Employees'
144 Retirement System within 60 days with the specific identifying

147 Section 2. This act shall become effective on the first
148 day of the third month following its passage and approval by
149 the Governor, or its otherwise becoming law.
