3	SYNOPSIS:
4	This bill would propose a local constitutional
5	amendment to the Constitution of Alabama of 2022,
6	relating to Dale County, that would allow mayors of
7	municipalities located in the county to participate in
8	the Employees' Retirement System under certain
9	conditions.

12	TO BE ENTITLED
13	AN ACT

15	This bill would propose an amendment to the
16	Constitution of Alabama of 2022, relating to Dale County, to
17	allow mayors in municipalities in the county to participate in
18	the Employees' Retirement System under certain conditions.
19	BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:
20	Section 1. The following amendment to the Constitution
21	of Alabama of 2022, is proposed and shall become valid as
22	Section 23-8.01 of the constitution when all requirements of
23	this act are fulfilled:

25	§23-8.01
26	In Dale County, the mayor of a municipality that
27	participates in the Employees' Retirement System of Alabama

29 upon the same terms and conditions as may be specified by law 30 for any other employee of the municipality in the same 31 retirement system. A mayor holding office at the time of the 32 ratification of this amendment shall be eligible to purchase 33 service credit in the Employees' Retirement System for the 34 time the official has served in the current office. No person 35 may participate in both a supernumerary program and the 36 Employees' Retirement System based on the same service.

37 Upon ratification of this constitutional amendment, the Code Commissioner shall number and place this amendment as 38 39 appropriate in the constitution omitting this instructional paragraph and may make the following nonsubstantive revisions: 40 change capitalization, spelling, and punctuation for purposes 41 42 of style and uniformity; correct manifest grammatical, 43 clerical, and typographical errors; and correct incorrect 44 cross-references.

45 Section 2. An election upon the proposed amendment 46 shall be held at the 2024 Presidential Preference Primary 47 Election in accordance with Sections 284 and 284.01 of the 48 Constitution of Alabama of 2022, and the election laws of this 49 state.

50 Section 3. The appropriate election official shall 51 assign a ballot number for the proposed constitutional 52 amendment on the election ballot and shall set forth the 53 following description of the substance or subject matter of 54 the proposed constitutional amendment:

55 "Relating to Dale County, proposing an amendment to the 56 Constitution of Alabama of 2022, to allow mayors to
