

## MedImpact's Specialty Network for PEEHIP

MedImpact administers PEEHIP's specialty drug program. Under the PEEHIP prescription drug benefit, specialty medications should be filled at a participating specialty pharmacy. If you are taking a medication that is on the PEEHIP Specialty Drug List, you can use one of the participating specialty pharmacies listed below. PEEHIP and MedImpact are dedicated to ensuring that you have all the resources needed to confidently manage your therapy and support successful outcomes. As a PEEHIP covered member, you have access to specialized services offered through MedImpact's Specialty Network for PEEHIP. These services include:

- ✓ Patient care representatives who are knowledgeable about your therapy and your health plan's coverage criteria;
- ✓ Experienced patient assistance representatives to guide you in seeking financial assistance if you cannot afford the cost of your medication or copay;
- ✓ Management of your plan's prior authorization requirements;
- ✓ 24-hour on-call phone support from licensed clinical staff;
- ✓ Educational materials and supplies needed to administer your therapy;
- ✓ Prompt, discreet, and secure medication delivery to your home or other location of your choice at no additional cost to you;
- ✓ Follow-up calls once you begin therapy to find out if you have questions, taking your medication(s) properly or experiencing any side effects;
- ✓ Multilingual translation services if needed.

To enroll, please call to speak with a pharmacy representative. They will reach out to your healthcare provider to get a new prescription for you or have your specialty prescriptions transferred from your current pharmacy. ### **Bleeding Disorders**

Effective February 1, 2019, Blue Cross Blue Shield will manage the Hemophilia Drug Management Program for all hemophilia medications covered under PEEHIP. This means your hemophilia medications will no longer be filed under your pharmacy benefit; all claims instead will be filed under your medical benefit. No copayment will be charged for hemophilia medications since they will process under the medical benefit. Under this program, hemophilia medications will be filled through Option Care Specialty Pharmacy, a participating provider for Blue Cross. **Additional Information for the Active Members and Non-Medicare Eligible Retirees**

When using a participating specialty pharmacy, you will be responsible for your copayment and PEEHIP will pay the remainder of the costs. If you choose to use a pharmacy that does not participate in MedImpact's Specialty Network for PEEHIP, you will be responsible for paying 100% of the costs up front. You may then submit a Direct Member Reimbursement claim to MedImpact and you will be reimbursed no more than the MedImpact contracted rate less your copayment.
