How to sign up for your online account:

- 1. Visit retiree.uhc.com/peehip and click on the Sign in or register button and then click Register Now on the next screen.
- 2. Enter your first and last name, date of birth, ZIP code, UnitedHealthcare[®] member ID number, and click **continue**.

- 3. Create your username and password, enter your email address, and click **create my ID**.
- 4. For security purposes, you will be asked to verify your account by email, call, or text:
 - If by email, follow the instructions in your confirmation email.
 - If by call or text, enter the code you receive into the website page.

Make sure to write down your username and password and keep them in a safe place. You will need them each time you sign into your account.

HAPPY NEW YEAR from the PEEHIP Wellness Program

ow is a great time to get a jump start on taking care of your physical health. One of the best ways to do this is to get a **FREE wellness screening** early in the year. A wellness screening can help to detect and identify unknown health issues you may have that can cause major health problems in the future. In addition, getting a wellness screening will earn your waiver of the \$50 monthly wellness premium.

As a reminder, all members and covered spouses enrolled in the PEEHIP Hospital Medical Plan Group #14000 administered by Blue Cross Blue Shield must get a wellness screening by August 31, 2023, to earn the \$50 monthly wellness premium waiver effective October 1, 2023.

A free wellness screening can be obtained annually from:

• An Alabama Department of Public Health (ADPH) worksite clinic or county health department. Visit the

ADPH online screening calendar at https://dph1. adph.state.al.us/publiccal/ to learn when and where screenings will be offered at your workplace or in your area.

- A participating pharmacy. A list of participating pharmacies can be found at rsa-al.gov/peehip/wellness.
- Your primary care physician. You will need to take one additional step to receive the monthly wellness premium waiver – have your doctor complete a HEALTHCARE PROVIDER SCREENING FORM (HPSF) and fax or mail it directly to the ADPH Wellness Program. The HPSF can be found at rsa-al.gov/peehip/forms/. Your status toward earning your monthly wellness premium waiver will be available on your Member Online Services (MOS) log in at https://mso.rsa-al.gov under the Wellness Completion Status link. ●

Flex Filing deadline is January 15

here are only a few days left to submit a reimbursement request for funds in your 2022

Health Flexible Spending Account (FSA) and Dependent Care Reimbursement Account (DCRA). All requests for qualifying expenses incurred between October 1, 2021, through September 30, 2022, must be submitted to HealthEquity along with supporting documentation by January 15, 2023. Unused funds contributed to an FSA or DCRA plan cannot be refunded. Per IRS guidelines, PEEHIP will allow active



members to carry over up to \$550 of unused funds in their FSA to use on eligible expenses in the subsequent plan

year. However, any funds remaining in the DCRA and in excess of \$550 in the FSA after the deadline will be forfeited. To check the balance on your FSA and DCRA or submit a reimbursement request, go to https://learn.healthequity.com/peehip or download the HealthEquity mobile app. If you have any questions or need assistance filing your reimbursement request, please contact HealthEquity customer service at 877.288.0719.

The PEEHIP plan is offering an incentive for enrolling and participating in the Baby Yourself program.

PEEHIP will waive the \$200 deductible for the delivery of your baby for those members enrolling in the first trimester and completing the program. The \$25 copay for days 2 through 5 will still apply.
