Healthcare Services at Your Workplace

- ◆ As a reminder, wellness screenings and flu shots provided by the ADPH are the only medical healthcare services covered by your PEEHIP benefits when obtained at your workplace. Additionally, PEEHIP will soon allow Alabama Community Mental Health Centers (CMHCs) to offer many of their already covered mental health benefits onsite at your workplace. The benefits to be allowed at your workplace include services such as psychiatric diagnostic evaluations and individual and family therapy. Any other medical or mental health services provided by vendors at your workplace other than the ADPH or (CMHCs) will not be eligible for reimbursement. To avoid charges, please do not obtain medical or mental health services at your workplace from any other vendors.

Health FSA Carryover Funds Now Available

- ◆ If you enrolled in a Healthcare Flexible Spending Account (Health FSA) last plan year, the deadline to file for reimbursement was January 15, 2019. Any remaining funds not subject to the Carryover provision are forfeited. The Carryover provision allows you to carryover up to \$500 of unused funds remaining in your Health FSA to use in the new plan year. Carryover funds became available for use on February 15, 2019.
