RSA Temporary Power Shutdown

- At approximately 4:00 p.m., Friday, January 18, 2019, the RSA will have a power shutdown to improve its power infrastructure. This will cause the shutdown of the RSA phone system, Member Online Services (MOS), Employer Self-Service (ESS) portal, Contributions Reporting Application (CRA), and the RSA website. None of these systems will be available until power is restored.
 - ♦ We expect all systems to be functioning no later than **Monday, January 21.**
 - ♦ We greatly appreciate your cooperation in this matter as we perform an upgrade and maintenance to our external power feeds.

Flex Filing Deadline January 15

The deadline to file for reimbursement from your 2018 PEEHIP Flexible Spending Account (FSA) plan is January 15, 2019. If you were enrolled in the Health FSA or Dependent Care Reimbursement Account (DCRA) between October 1, 2017, and September 30, 2018, you must submit your reimbursement request by January 15, 2019, to avoid losing any flex funds from the prior plan year. Submit your request online or by mail. Any unused funds in excess of \$500 remaining in your Health FSA or your Dependent Care Reimbursement Account after the deadline cannot be refunded and will be forfeited.
