### **PEEHIP Open Enrollment begins July 1, 2018 and will end by the following deadlines:**

- ◆ **Online: September 10, 2018.** Open Enrollment ends midnight September 10, 2018. After this time, online Open Enrollment changes will not be accepted and the Open Enrollment link will be closed. Online enrollment at PEEHIP [Member Online Services \(MOS\) Website](#) is the preferred option because it is the easiest and most efficient method to enroll in or make changes to your coverage. No other enrollment method provides an enrollment confirmation page in real time upon enrollment.
- ◆ **Paper: August 31, 2018.** Open Enrollment ends August 31, 2018. Any paper forms or faxes postmarked after that date will not be accepted, without exception.
- ◆ **Flexible Spending Accounts: September 30, 2018.** Both paper and online Open Enrollment for flex plans end September 30, 2018.

  - ◇ Who is required to participate in the Wellness Program?
    - ◆ Active employees
    - ◆ Non-Medicare-eligible retirees
    - ◆ All covered spouses of active employees and non-Medicare-eligible spouses of retirees
  - ◇ Who is not required to participate in the Wellness Program?
    - ◆ Children
    - ◆ Medicare-eligible retirees and Medicare-eligible spouses of retirees
    - ◆ Any members who are not enrolled in the PEEHIP Hospital Medical (Group #14000) plan will not be charged any wellness premium related to the Wellness Program.
