Retirement Systems of Alabama, headquartered in Montgomery, Alabama (hereinafter "RSA").			
WHEREAS RSA possesses or houses information that is confidential	and proprie	etary to RSA or thei	

WHEREAS RSA possesses or houses information that is confidential and proprietary to RSA or their tenants (hereinafter "Confidential Information"); and

WHEREAS the Recipient is willing to receive disclosure of the Confidential Information pursuant to the terms of this Agreement for the purpose of <u>becoming an authorized user of the RSA Data Center Facility located at 445 Dexter Avenue, Montgomery AL.</u>;

WHEREAS the Recipient may be disclosed confidential information about the RSA Datacenter to include items such as but not limited to mechanical, electrical, security, and\or electronic drawings, procedures, schedules and any other form of information considered to be confidential belonging to the RSA, their tenants, and\or protected by law. Information may be disclosed to Recipient as a result of becoming an authorized tenant or contractor of the RSA Datacenter or inadvertently disclosed as a result of utilizing a collocated datacenter.

NOW THEREFORE, in consideration for the mutual undertakings of the RSA and the Recipient under this Agreement, the parties agree as follows:

- 1. Disclosure. RSA agrees to disclose, and Recipient agrees to receive the Confidential Information.
- 2. Confidentiality.
- 2.1 No Use. Recipient agrees not to use the Confidential Information in any way except for the purpose set forth above.
- 2.2 No Disclosure. Recipient agrees to use its best efforts to prevent and protect the Confidential Information, or any part thereof, from disclosure to any person other than Recipient's employees having a need for disclosure in connection with Recipient's authorized use of the Confidential Information.
- 2.3 Protection of Secrecy. Recipient agrees to take all steps reasonably necessary to protect the secrecy of the Confidential Information, and to prevent the Confidential Information from falling into the public domain or into the possession of unauthorized persons.
- 3. Limits on Confidential Information. Confidential Information shall not be deemed proprietary and the Recipient shall have no obligation with respect to such information where the information:
- (a) was known to Recipient prior to receiving any of the Confidential Information from RSA;
- (b) has become publicly known through no wrongful act of Recipient;

- (c) was received by Recipient without breach of this Agreement from a third party without restriction as to the use and disclosure of the information;
- (d) was independently developed by Recipient without use of the Confidential Information; or
- (e) was ordered to be publicly released by the requirement of a government agency.
- 4. Ownership of Confidential Information. Recipient agrees that all Confidential Information shall remain the property of RSA, and that RSA may use such Confidential Information for any purpose without obligation to Recipient. Nothing contained herein shall be construed as granting or implying any transfer of rights to Recipient in the Confidential Information, or any patents or other intellectual property protecting or relating to the Confidential Information.
- 5. Term and Termination. The obligations of this Agreement shall be continuing until the Confidential Information disclosed to Recipient is no longer confidential. This agreement shall continue in the event the above stated purpose service agreement is ended for any reason.
- 6. Survival of Rights and Obligations. This Agreement shall be binding upon, inure to the benefit of, and be enforceable by (a) RSA, its successors, and assigns; and (b) Recipient, its successors and assigns.
